

## MARKO DJOGO - BIOGRAPHY (CURRICULUM VITAE)

Marko Djogo was born in Sarajevo on 30 November 1983. There he started his primary education (Vladimir Peric - Valter public school), which, due to war conditions, he finished at Pale with excellent success. After that, he attended the General High School at Pale and he completed it with excellent success in 2002. The same year he started his education at the Faculty of Economics in East Sarajevo. He completed his academic studies in 2006 as the student of generation with average grade of 9.13. In 2006, he entered postgraduate (master) studies, the major course: Corporate Finance and Banking at the Faculty of Economics in East Sarajevo. He graduated in 2009, and the title of his final paper was *Impact of Financial Liberation at Economics of Countries in Transition with Review of Bosnia and Herzegovina*, under supervision of the professor Novo Plakalovic, full professor at the Faculty of Economics in East Sarajevo. During postgraduate studies he was also the student of generation with average grade of 9.70.

In April 2013, he received his PhD in economy at the Faculty of Economics in East Sarajevo after he had successfully defended his doctoral thesis entitled *Impact of Exchange Rate Regime on Balance of Payment of Bosnia and Herzegovina, Serbia and Croatia*, under supervision of the professor Radovan Kovacevic, full professor at the Faculty of Economics in Belgrade.

Since February 2007 he has been employed at the Faculty of Economics in East Sarajevo, first as assistant, later as senior assistant and finally, since October 2013, as assistant-professor. His fields of interest include International economy and finance, macroeconomic competitiveness etc.

Since 2011 Marko Djogo has been a member of Association of economists of the Republic of Srpska – SWOT, where he started to work as external associate-analyzer of situation in financial sector and editor of Association quarterly magazine. In 2012 he became the chief of Department for banking in the Association of economists.

From November 2013 to October 2014, Marko Djogo was an advisor for economic issues to the Chairman of Parliamentary Assembly of Bosnia and Herzegovina, House of People.

Since September 2014, Marko Djogo has worked as vice-dean for teaching at the Faculty of Economics in East Sarajevo. He is also a visiting professor at the Faculty of Economics in Podgorica (Monte Negro University), the Faculty of Economics in Brcko and Faculty for Business Economy in Bijeljina.

Marko Djogo is also author and co-author of two books (*Story about money: money and currency policy through history*, Association of economists of the Republic of Srpska, Banja Luka, 2012; *National economy*, the Faculty of Economics in East Sarajevo, 2007), five articles in leading national magazines, six papers at international conferences and five articles in classified national magazines in BiH and abroad (Republic of Serbia, Republic of Turkey).

Marko Djogo has been working at CCI (Center of Civil Incentives) project Budget to people, as external consultant in charge of analyzing the budget cycles at BIH level, entity level (Republic of Srpska), Banja Luka city and Municipality of Tuzla.

His newspaper columns in Nezavisne novine (over 55 columns by the end of 2014) in which he argues about economic issues of Bosnia and Hercegovina, brought his work to public attention.

Marko Djogo speaks English language very well but not as well as his national tongue (at British Council APTIS Reading test he got the highest degree – C, he also possesses Cambridge Center Banja Luka, School of English, Certificate in Upper Intermediate Level, Council of Europe Level: B2).

In marriage with Tamara Starovlah Djogo, Marko Djogo has three children, two sons Andrija (2010) and Jakov (2012) and a daughter Tajna (2014).
